Purpose of the processing The personal data supplied by you are necessary for the fulfilments required by law, for the keeping of the electronic and / or paper enrolled list, including the appropriate communications to institutions such as insurance (to ensure the enrolled) and the Sports Federation (to register the member) and for various communication regarding internships, courses and promotions by the Ateneo danza srl sportiva dilettantistica.

Methods of processing and storage The processing of data is based on principles of correctness, lawfulness and transparency and data minimization (privacy by design); it may be carried out either manually or through automated procedures designed to store, process and transmit them and will take place through appropriate technical and organizational measures, as far as reason and to the state of the art, to guarantee, among other things, security, confidentiality, integrity, availability and resilience of systems and services, avoiding the risk of loss, destruction, unauthorized access or disclosure or, in any case, illicit use, as well as by reasonable measures to cancel or correct inaccurate data in relation to the purposes for which are treated. Your personal data will be kept for the period of time necessary for the achievement of the purposes for which they are collected and processed.

Scope of communication and dissemination We also inform that the collected data will never be disclosed and will not be communicated without your explicit consent, except for the necessary communications that may involve the transfer of data to consultants or other subjects for the fulfillment of the obligations law.

Rights of the interested person At any time, you may exercise, pursuant to art. 7 of Legislative Decree 196/2003 and articles from 15 to 22 of EU Regulation no. 2016/679, the right to: a) request confirmation of the existence or otherwise of their personal data; b) obtain information on the purposes of the processing, the categories of personal data, recipients or categories of recipients to whom the personal data have been or will be communicated and, where possible, the retention period; c) obtain the correction and deletion of data; d) obtain the treatment limitation; e) obtain data portability, ie receive them from a data controller, in a structured format, commonly used and readable by automatic device, and transmit them to another data controller without hindrance; f) oppose the processing at any time and also in the case of treatment for direct marketing purposes; g) to oppose an automated decision-making process concerning individuals, including profiling. h) ask the data controller to access personal data and to rectify or cancel them or limit their processing or to oppose their processing, in addition to the right to data portability; i) withdraw the consent at any time without prejudice to the lawfulness of the treatment based on the consent given prior to the revocation; j) propose a complaint to a supervisory authority.
